Chinese High Yield Property Bonds Outperformed



Highlights:

1. Yields for B-rated Chinese high yield property bonds dipped slightly
2. Indonesian quasi-sovereign bonds added in response to the country's improved macro condition
3. New issuance of Asian investment grade and Asian high yield bonds offer attractive premiums

- The Fund adopts unconstrained strategy, with maximum flexibility allowed in allocating assets among corporate bonds, government bonds, high yield bonds and investment grade bonds, actively hunting for alpha opportunities.
- Seeks stable dividends and exploits appreciation potential of Asian bonds.

Market Review and Outlook

Review of Interest Rate Market

- U.S. Treasury bonds rallied as various Federal Reserve members including the chairman, Jerome Powell, issued dovish comments on the path of interest rate hikes.

Asian High Yield Bonds

- Chinese high yield property outperformed as yields for B-rated names dipped slightly. Chinese high yield industrial bond yields further increased due to headline news and concerns about refinancing.
- Indonesian high yield industrial and property bonds yields continue their gradual rise since October, mainly as a result of weaker third-quarter results. Indian bonds have largely remained flat.

Market Outlook

- We remain cautious due to trade war concerns, volatility in emerging market currencies, and tight onshore funding for trusts and privately-owned companies. We continue to see attractive valuations across some higher-quality names.

Investment Strategy

- The Fund has been picking up bonds in the primary market, as we are seeing attractive new issue premiums in both the Asian investment grade and Asian high yield segments.
- The Fund added exposure in Indonesian quasi-sovereign bonds in response to attractive valuations and the country's improved macro condition.
- The Fund maintains a defensive strategy, with a high yield security selection skewed more toward defensive short-dated bonds and issuers with better credit quality.
