

Fund Report (Dec 2022)

Important note:

- 1. BU RMB Core Bond Fund ("the Fund") is a sub-fund of BU Investment Series OFC ("the Company"), which is a public open-ended fund company ("OFC") (registration number OF11) regulated under the laws of Hong Kong, with variable capital and limited liability and segregated liability between sub-funds.
- The Fund seeks to achieve income and long-term capital growth by investing in debt securities and other assets that are denominated in RMB and other currencies.
- 3. The Fund invests in debts or fixed income securities are exposed to interest rates, credit/counterparty, downgrading, volatility and liquidity, valuation and sovereign debt, credit rating risks and credit rating agency risk (for mainland China onshore debt securities) risks which may adversely affect the price of the debt securities.
- 4. The Fund may invest in below investment grade, or rated BB+ or below by a China credit rating agency, or non-rated debt securities, which are subject to greater volatility and liquidity risks than higher-rated securities.
- 5. The Fund's investments are concentrated in China and may be subject to high concentration risk and more volatility than that of funds having a more diverse portfolio of investment. Market Outlook

November saw a positive turn in the twin challenges China had been facing: a beleaguered property market and stringent pandemic policies that weighed on economic activities. Following the launch of the country's "three arrows" package of credit, bond and equity financing, our investment teams expected China's property market could see less liquidity stress moving forward. Although there will be a lag effect before property sales can regain momentum, we believe China's relaxation on its pandemic requirement could eventually buoy home sales. Our investment teams will continue to gauge how the supportive measures will be implemented and keep a close eye on the market development.

The easing of mobility curbs spurred hopes that the country could be on the road to economic recovery, and riskier assets may gradually attract inflow, supporting the Renminbi.

Investment Strategy

In face of a spate of favourable property policies, the investment teams added beta positions through high-yield property bonds. The fund remained neutral on RMB at the moment and do not overweight USD as we believe the greenback's one-sided strength is coming to an end given the rate hike cycle began to tail off.

Reopening measures and reflation theme are factors that could possibly send onshore bond yields higher, prompting the fund to maintain underweight in RMB duration on rising yield expectations. In November, the PBOC cut reserve requirement ratio for most banks by 25bps, injecting liquidity into the market to stimulate growth. We expect China's monetary policy will stay accommodative to support the economy.
